Consent Form in Terms of the Protection of Personal Information Act 4 of 2013 (POPIA)

Consent to Use Personal Information

By agreeing to the terms of this information form, you hereby voluntarily authorise PRESIDENT HIGH SCHOOL to:

- Process your personal information as well as that of the learner (including names, street address, telephone numbers, and any other information you provide to the school).
- Processing includes receiving, recording, organising, sorting, storing, updating or modifying, retrieving, altering, consulting and using, outsourcing, and transferring to third parties, disseminating by transmission, distribution, or making available in any other form, or the merging, linking, restricting, degrading, erasing, or destroying of information.
- Process your personal information for purposes required by your relationship with the school, or as required by law, provided that such personal information will only be processed by the school or an authorised third-party operator for purposes related to the aforementioned relationship, or any third party where required by applicable law.
- This consent is effective immediately and will remain in force until one of the conditions in paragraph 8 of the Personal Information Protection Policy is fulfilled. Personal information may only be processed if it is adequate, relevant, and limited to the purpose for which it is processed, and if the processing is done in accordance with the relevant provisions of POPIA. The purpose of processing information must be related to a function or activity of the school.
- In addition, you hereby acknowledge that PRESIDENT HIGH SCHOOL collects and processes personal information regarding the proper functioning, management, and control of the school as prescribed by the South African Schools Act 84 of 1996 and other relevant education legislation and policies.
- The type of information will depend on the purpose for which it is collected and will only be processed for that purpose.

In terms of section 11 of POPIA, personal information may only be processed in the following circumstances:

- If the data subject, or a competent person if the data subject is a child, consents to the processing.
- If processing is necessary for the performance of actions for the conclusion or fulfilment of a contract in which the data subject is a party.
- If processing complies with a legal obligation imposed on the school.
- If processing protects a legitimate interest of the data subject.
- If processing is necessary for the performance of a public law duty.
- If processing is necessary to pursue the legitimate interests of the school.

Your rights under this consent:

You have the following rights:

The right to know what information is held, how it is used, and when the school will disclose it. All this information is contained in our Personal Information Protection Policy and our Privacy Policy, which

are available and can be obtained from our offices or on our website.

The right to correct your details. The school will try to keep your information up to date. However, if any of your details change, please notify us so that our records can be as accurate as possible.

The right to withdraw your consent. You may withdraw the consent you give us under this form at any time. Your withdrawal must be in writing and directed to the principal. Withdrawn consent is not retroactive and will not affect any previous or existing use of your information.
